



- > 7 Days to call the sales office to schedule a visit
- 14 Days to submit a Final Application for Affordable Housing to Piazza & Obtain a Mortgage pre-approval letter from a qualified financial org.
- Applicants must meet deadlines to keep priority
- Final Applicants are subject to:
 - Terms of their Purchase Agreement with the Seller
 - Mortgage Requirements of their Lender
 - Affordable Housing Criteria per Piazza





- Being number 1 does not guarantee a home
- Being number 100 does not exclude you
- The household applying MUST be the same as the household residing
- Affordable home MUST be the principal residence
- Buyer must abide by restrictions
- Resale process and the maximum re-sales prices are governed by law
