

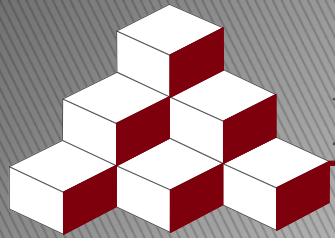

# Collignon Estates

- ❖ Priority Number, Regional & Veterans' Preference, Level of Affordability
- ❖ Low Priority Number? Watch for Final App in Email
- ❖ For those who receive a Final Application...
  - ✓ Contact the property leasing office within 7 days
  - ✓ Submit Final Application to Piazza within 14 days
- ❖ Applicants must meet deadlines to keep priority
- ❖ Final Applicants are subject to:
  - ✓ Tenant Selection Criteria per the Landlord
  - ✓ Affordable Housing Criteria per Piazza

# Collignon Estates

- ❖ Being number 1 does not guarantee an apartment
- ❖ Being number 20 does not exclude you
- ❖ Beyond number 1,000? Probably not.
- ❖ Remainder on Waiting List for future RE-rental for this property only (Usually a very long wait)
- ❖ Household applying / residing MUST be the same
- ❖ Apartment MUST be principal residence of tenant
- ❖ Maximum rent increases are regulated



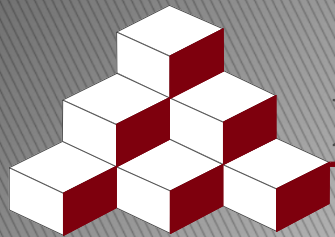
